1. Scope of work

- a. Include costing for a baseline Occupational Hygiene service - Hazard Identification and Risk Assessment at the ABX Building (Pretoria) and the MBOD (Johannesburg)
- b. Medical screening services for individual employees is (at risk and dependent on consent from employees) and will need X-rays and other diagnostic tests (vision, lung function and audiometry) on site at ABX and MBOD. Costing needed on an individual screened noting that some full-time staff (nurses and administrators) are provided by the service provider and additional professionals will need to be sourced for the screening of the individual employees.
- c. Sessional hours for the following categories of professionals as follows:
 - i. Sessional project manager costed **hourly**
 - ii. Medical doctors (**1 X four-hour session** by 1 doctor on one day and another **1 X four-hour session** by 1 doctor on another day per week at ABX; **1 X four-hour session** by 1 doctor per week at MBOD)

 - iv. Occupational social workers (**1 X 4 – hour session** by 1 social worker for 1 day a week at ABX and **1 X 4 - hour session** by 1 social worker for 1 day a week at MBOD)
 - v. **Note above sessional services to be reviewed quarterly and decision made by NDOH about changes (if needed)**
 - vi. Occupational hygiene professional services costed **hourly**
 - vii. Occupational therapy services professional costed **hourly**
 - viii. **Psychosocial** Telehealth support costed **hourly**
 - d. **Note Removal of Telehealth support** in Primary health care services – not needed.
 - e. **Note changes to evaluation criteria and scoring**


