1. In terms of section 9 of the mandatory requirements, a valid letter for tender purposes of certificate of compliance for Unemployment Insurance Fund (UIF) is no longer required.
2. In terms of cleaning requirements, the following are added:
 - The real square meters for carpeted areas that need deep cleaning – 16m² x 4 offices
 - For Hygiene service - Disposing of soiled sanitary (SHE) pads is done by a certificated professional for hygienic purposes.
 - Each female bathroom cloak room with a SHE bin must be provided with a pack of sanitary disposal plastics – (80 cloak rooms still 20 bags per box of 5)
 - Additional 3 floor scrubbing pads.
 - Tile cleaner – 25L x 2 monthly
 - Cleaning cloths – Provide each cleaner with 3 x cloths – monthly
